Revisionsrapport "Uppföljande granskning av år 2021"

Revisionen har via KPMG genomfört en uppföljning av genomförda granskningar under år 2021. Vår sammanfattande bedömning utifrån granskningens syfte är att en del åtgärder har vidtagits i enlighet med rekommendationerna. Däremot bedömer vi att det finns utrymme att skapa vidare förbättring.

Mot bakgrund av vår granskning rekommenderar vi kommunstyrelsen att:

Avseende granskning av lärares arbetsmiljö:

att säkerställa att arbetet med målstyrning i Stratsys fullföljs,

att beakta och vidta åtgärder för arbetsmiljön som ett led i det strategiska arbetet kring arbetsmiljö och kompetensförsörjning,

att tillse att arbetet med att säkerställa en likvärdig utbildning och god undervisningsmiljö fortsätter aktivt,

att tillse att åtgärder vidtas för att säkerställa systematik i uppföljningen av arbetsmiljöarbetet.

Avseende granskning av upphandling:

att se över möjligheten för ytterligare en tjänsteperson att delta i upphandlingsutbildning,

att säkerställa att controllerfunktionen regelbundet används för uppföljning och utvärdering av avtal och inköp.

Revisionen hemställer om att kommunstyrelsen lämnar synpunkter avseende vilka åtgärder som beräknas att vidtas utifrån rekommendationerna.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
